

This Supplier Agreement ("Agreement") is entered into between **Wild Shropshire Restaurant** ("The Restaurant") located at 25-27 Green End, Whitchurch, Shropshire, SY13 1AD, and **Supplier** ("Supplier"). The agreement outlines the terms and conditions governing the provision of goods and services to Wild Shropshire Restaurant.

## 1. Purpose of Agreement

This Agreement establishes the framework under which Supplier will provide sustainably sourced, high-quality goods and/or services to Wild Shropshire Restaurant in line with its ethical, environmental, and operational standards.

## 2. Scope of Supply

Supplier agrees to supply the following goods and/or services to Wild Shropshire Restaurant, as specified in purchase orders:

- **Products:**

  - **Corrective Action:** Request corrective action, such as quality improvements or delivery adjustments.

## 10. Term and Termination

- **Duration:** This Agreement is valid for a period of **12 months**, starting from the date of signing.
  - **Termination:** Either party may terminate this Agreement with **60 days** written notice.
- 

## 11. Dispute Resolution

Any disputes arising from this Agreement shall be resolved through good-faith negotiations between the parties. If a resolution cannot be achieved, both parties agree to mediation or arbitration in accordance with UK law.

## 12. Confidentiality

Both parties agree to maintain the confidentiality of any proprietary information shared in the course of this Agreement, including but not limited to pricing, sourcing strategies, and customer data.

## 13. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the United Kingdom.
